

## AWARENESS SOFTWARE LIMITED: COOKIES POLICY

### 1. Who are we?

1.1. Access to and use of our websites (the "**Websites**"), either as a guest or a registered user, is subject to this Cookies Policy. In this Cookies Policy, "**we**", "**us**" and "**our**" means Awareness Software Limited (a company registered in England and Wales with registered number 03705875 and registered office at The Copper Room, Deva Centre, Trinity Way, Manchester, M3 7BG), who operates the Websites. ### 2. What does this Cookies Policy apply to?

This Cookies Policy applies to all use of the Websites.

### 3. Information about our use of cookies

- 3.1. The Websites use cookies. Cookies are tiny text files which identify your computer to our server as a unique user when you visit certain pages on the Websites and they are stored by your Internet browser or your computer's hard drive. Cookies can be used to recognise your Internet Protocol address, saving you time while you are on the Websites. This helps us to provide you with a good experience when you browse the Websites and also allows us to improve the Websites based on your experience.
- 3.2. We only use cookies for your convenience in using the Websites and not for obtaining or using any other information about you (for example targeted advertising). Your browser can be set to not accept cookies, but this would restrict your use of the Websites.

- 3.5. Please also note that our suppliers and partners may also use cookies, over which we have no control. To manage these cookies you would need to use their cookie management tool or follow instructions in 3.3 above.

<b>Cookieyes</b>	Strictly necessary.	Up to 2 years from setup/update	This cookie is used to track the choices make in the CookieEyes cookie selector.
<b>CONSENT NID _ga _ga_gtag_UA_106401005_1 _gid cc_analytics cc_necessary</b>	Analytical.	Up to 2 years from setup/update	Google Analytics cookies. These cookies are used to collect information about how visitors use the Website. We use the information to compile reports and to help us improve the Website. The cookies collect information in an anonymous form, including the number of visitors to the Website, from where visitors have come to the Website and the pages they visited once at the Website. Google may, at their discretion, change the names of these cookies without our knowledge.

Any changes we may make to this Cookies Policy in the future will be posted on the Websites and, where appropriate, notified to you by e-mail. Each time you enter the Websites, you agree that the Cookies Policy current at that time shall apply to all information held by you.
